
# Meeting Topic RIM Legislation and ISO Standards



Our Speaker
Julie Gable, CRM

This presentation is an overview of the best known and most widely-cited RIM-related standards and regulations in the U.S. and other countries. It will touch on SOX, PIPEDA, and the USA Patriot Act and show how they have influenced more recent regulations such as Dodd Frank and Right to Know laws. We will look at how international and industry standards evolve, with emphasis on ISO 15489, ISO 23081 (metadata management) and ISO 15836 (the Dublin Core) and will discuss the difference between best practice standards and software product-related standards such as DoD 5015.2 and MoReq. The point is to provide a reference list and conversational knowledge of major standards and regulations that any records manager should be familiar with. Attendees will learn:

- Broad based and industry specific regulatory requirements
- Important records-related standards
- How standards and laws are related


